Cornerstone of Tax Relief Thrown Out

Property Tax relief has been the focus of government in Florida for the last couple of years since the housing price boom inflated property taxes so rapidly, forcing some owners to sell. In June it was the subject of a Special Session of the Legislature after the normal session failed to reach a settlement during its allocated time. Cities and Counties were told to cut or cap their tax collection revenues, but the cornerstone of the legislation was placing a constitutional amendment on to the presidential primary ballot on January 29th. Voters were to be asked to approve a super-sized homestead exemption. This would give resident homeowners a one-time chance to keeping their existing \$25,000 exemption (before the taxable rate kicks in) and a 3% annual cap (Save Our Homes - SOH) on taxable increases. This current system means that neighbours in similar properties pay very different amounts in property taxes for the same services. The alternative on offer, and endorsed by the Florida Association of Realtors and promoted by Governor Crist, is to have a Super-Sized exemption of 75% of a home's value up to \$200,000, and an additional 15% of the value between \$200,000 - \$300,000. The SOH cap would be eliminated. This would be a one-time only choice for the current home of the resident, upon moving they would automatically go into the new system if this is approved. A Circuit Court Judge in Leon County has said the amendment should not appear on the ballot in its current form, saying that it is too misleading. Mayor Eric Hersh of Weston had challenged the amendment. In its decision, the court ruled that the ballot summary read by voters calls for "preserving application of Save-Our-Homes provisions until an irrevocable election is made." The Judge called that misleading, saying the amendment would actually phase out the existing property tax. The government has filed an appeal in the Supreme Court but it faces a deadline of October 28th. Under Florida law, a proposed change to the constitution must be created at least 90 days before the election in which it is to appear. Another Special Session of the Legislature is planned for late October, (the fourth special session this year) so a re-write could be accomplished in time. If a ruling is not forthcoming from the Supreme Court before January 29th the question could still go to the voters 'as is'.

Committee to Monitor Rentals

On October 1st the Marco Island city council meeting discussed possible regulation of short-term rental properties together with existing code requirements. There is currently no regulatory ordinance of rental homes, but codes do cover noise levels, parking rules and the number of un-related individuals who can live in a single family residence. Following many complaints from residents, and at the suggestion of one of the councillors, a committee was formed to monitor the rentals. It is not clear at this time what teeth, if any, the committee may have. The committee is made up of representatives from the Marco Island Area Association of Realtors, the chamber of

commerce, a rental agency, four members of the general public, Police Chief Roger Reinke, Code Enforcement Director Eric Wardle, Community Development Director Steve Olmsted and a nonvoting chairperson from City Council.

News Roundup

Walt Disney Worlds Contemporary, Old Key West and Saratoga Springs resorts have achieved Green Lodging status bringing to 36 the number of Florida hotels with this status.

This probably won't surprise many of you – a survey by Barclays and YouGov has discovered that 41% of Brits now save money by using the holiday home or flat of friends or family and rather worryingly – 13% of those surveyed admitted to only staying friends so that they could make use of the facilities! It is estimated that around £4 billion is saved every year by Brits 'using' free accomodation!

Figures released by Orlando International Airport show that the number of passengers increased this June by 5.21% over June 2006, and that the first 6 months of the year show overall passengers could exceed 35 million if continued for 12 months.

A group of 21 selected passenger airlines reported a system operating profit margin of 8.8 percent in the second quarter of 2007, the highest profit margin since 2000 and the first time since 2000 that airlines have had five consecutive profitable quarters, the Bureau of Transportation Statistics (BTS) of the U.S. Department of Transportation reported today in a release of preliminary data. The 21-carrier group consists of the seven largest network, low-cost and regional carriers based on operating revenue.

Virgin Atlantic will fit new Premium Economy seats in all its 747 fleet by Christmas taking the seats available per flight from 32 to 62. Premium Economy was introduced by Virgin in 1992 and has seen demand soar by 56% from 2000 to 2005.

As September drew to a close it looked as though the 'yield-is-king' fraternity had the upper hand, especially after the Fed slashed 50 basis points from its Funds Rate. The Yen was on the ropes and the Aussie and Kiwi Dollars were punching the air. In the meantime Sterling was fighting a lonely battle, trying to shrug off the effects of the first run on a UK bank since the 19th century. If Sterling manages to move ahead from here it will do so despite the growing threat of a rate cut of its own. But it probably will move ahead; the Dollar still looks shaky.

As the downturn in the U.S. economy and the sub-prime mortgage crisis continues to reverberate around the world the U.S. travel industry is asking – how will it affect us? Economic forecasters had been predicting increases in the number of jobs in the U.S. of 110,000 for August 2007, instead 4,000 jobs were cut and this is bound to have some kind of knock-on effect on a luxury such as travel, but maybe not for some months. Analysts at Pricewaterhouse Coopers have revised their forecast for growth in demand in hotel room occupancy downwards by only 0.1% from 1.4% to 1.3% growth for the remainder of the year.

For that price you will receive 4 large colour photos, 27 searchable property features, a customised map and availability calendars, and free text message (SMS) alerts when you receive email enquiries.

Pulte Homes has topped the rankings by J D Power and Associates of customer service and satisfaction. Centex Homes were second, followed by David Weekly, Beazer Homes and K B Homes in fifth. To qualify for ranking the builder had to have closed on at least 150 properties during 2006 in Polk, Orange, Lake, Osceola, Volusia, Seminole and Brevard counties.

Foreclosures in Florida continue to rise at astonishing rates. In August there were 33,392 foreclosure filings, up 70% from July 2007 and more than twice the total of a year ago.

Following this year's Consumer Choice Act which removed many of the cumbersome licensing hurdles that Cable companies had to go through to service an area, AT & T has announced a \$750 million investment in Florida. A new Cable and Internet service will be rolled out across Florida.

Kolcraft has recalled around 425,000 travel cots/play pens following the death of a child. All of the cots have a changing table with restraint strap. The child became entangled in the restraint strap hanging below the table after being put in the cot whilst the table was still attached. Twelve different Kolcraft travel cots are included in the recall. They can be seen at www.cpsc.gov and follow the link for *Play yards* – or call (888) 655-8484.

Airport security screeners stepped up scrutiny of remote-controlled toys on October 1st after authorities said terrorists could use them to detonate bombs. "Credible specific information" indicates that terrorists are looking at using remote devices that can trigger an explosive, the Transportation Security Administration (TSA) said in a statement. The agency said there's no indication of a timeline or a plot. "Intelligence and law enforcement have developed information that terrorists are interested in using remotecontrolled toy vehicles as part of their tactics," TSA chief Kip Hawley said in an interview. "There were some dots that came together" he continued. Airline passengers including children who carry remote-controlled toys to checkpoints may face additional screening, such as a patdown search. Remote devices are still allowed in airplane cabins, though the TSA encourages travellers to put them in checked bags.

Oct 1st was the deadline for insurance companies to submit their rate filings as required by law. They are supposed to pass along savings to customers as part of the insurance reforms passed earlier this year by the Legislature. We will have news on approved filings next month.

Insurance

The Florida Supreme Court ruled on 20th September that insurers are not liable for flood-related damage from the 2004 hurricanes, reversing the decision of 2 district courts and affecting hundreds of civil cases. The impact of this ruling carries over to hundreds of other pending wind – versus – flood cases, including a class action lawsuit against the state-run Citizens Property Insurance.

Just prior to the 2004 hurricane season a district court in south Florida ruled that under Florida's valued policy law, insurers must pay policy limits when a covered property is destroyed, even if the damage was partly caused by an uncovered peril - such as flood. As a result of last months' ruling, homeowners will now have to collect loss payments from wind **and** flood insurers – who do not always agree on the percentage of damage caused by their peril. The unanimous opinion written by Justice Charles Wells states Florida's 108 year old *valued policy law* was designed to prevent haggling over the value of destroyed property, not to cover perils that were not insured. He wrote "an insurer is liable for a loss by a peril covered under the policy for which a premium has been paid."

Florida's 'No Fault' auto law expired under its Sunset provision on October 1st. Despite knowing that this day was coming, it has now been decided to add a review of the law, with a mind to bringing it back, to the Special Session of the Legislature commencing October 3rd to address the State Budget. Auto insurers are furious, because if the law is reinstated, all the work preparing for the change-over will have to be undone. Computer programs which have been programmed to account for the ending of the law will have to be rewritten to take account of any changes brought about by reprising the law. Of course all this will cost money, which will in turn be passed on to customers!

In another showcase of research and due diligence, it has been discovered that Citizens insurance cannot offer homeowners discounts due on their premiums for storm-proofing their homes! Last year the Florida Cabinet instructed insurance companies, including Citizens, to double exisiting discounts for protecting their homes by September 1st 2007. Unfortunately, under Citizens current system the discounts are not capped but cumulative, which could actually present the possibility of the insurer having to pay the homeowner for his policy! To prevent this, officials have decided not to implement any

discounts for now. The discounts were approved in May, but it was not discovered until 7 weeks ago, when they started trying to make the changes, that there was a problem.

Hurricane Season

"For the 2007 Atlantic hurricane season, NOAA scientists predict 13 to 17 named storms, with seven to 10 becoming hurricanes, of which three to five could become major hurricanes of Category 3".

This was the forecast back in June, but the season began quietly. Tropical Storm Andrea slipped in early on 10th May, off the east of Florida. Tropical Storm Barry arrived in the Gulf of Mexico bang on time on the June 1st. We then had to wait nearly two months until July 31st for Tropical Storm Chantal to rise out in the Atlantic, dissipating without landfall. It was another two weeks before Hurricane Dean (Category 5) came along to much publicity over Mexico. At the same time Tropical Storm Erin rose from the Gulf and dissipated over San Antonio.

On August 31st Hurricane Felix (Category 5) followed a similar path to that of Dean across the Caribbean into Central America. In September activity really picked up with Tropical Storms Gabrielle, Humberto, Ten (un-named), Ingrid, Jerry, Karen and Hurricane Lorenzo (Category 1), September finished with Tropical Storm Melissa which was rather a damp squib! Touching wood whilst writing, none of these have affected Florida since the first two early on which really only brought heavy rains. That is not to say there has not been stormy weather in Florida just not actual named storms. Eustis was hit by a tornado that destroyed some 7 homes, and damaged over 100 others. It was considered an F1, a weak-to-moderate tornado on the Fujita scale.


Titusville City Council has voted to ban short-term rentals of less than three months. The prohibition applies to most residential zoning districts, although if a property is within 100 feet of a commercial district, the property owner can file an exemption.

Bank of Florida has successfully completed its transition and rebranding from Old Florida Bank to Bank of Florida following the merger in April this year.

Neiman Marcus is coming to University Town Center Mall in Sarasota. The 80,000-square-foot Neiman Marcus will be the luxury retailer's 45th store and it's eighth in Florida, the company's largest market. Since 2001, five of the nine new stores have been built in Florida.

After encouraging gains in the 1990s, populations of loggerhead sea turtles are now dropping, primarily because of commercial fishing, according to a federal review. The report stops short of recommending upgrading the federally threatened species to "endangered" status. But scientists and environmentalists say it should serve as a wake-up call about the future of loggerheads, which can grow to more than 300 pounds and are believed to be one of the oldest species. The Southeast — Florida in particular — is one of the two largest loggerhead nesting areas in the world; eggs are laid and hatched along beaches from Texas to North Carolina. The other major nesting area is in the Middle Eastern nation of Oman.

Twin cyclones formed in the balmy gulf waters off Marco Island on the afternoon of the 18th, hovering side by side before vanishing again. The two waterspouts appeared just after 4 p.m.,



giving Islanders enough time to marvel at the sight and snap a few photos.

Four homes in Sarasota are being given away for free – the catch is that the new owner must move them! Land, including the four homes, is being cleared for a new project called Citrus Square. The developers have said that if the houses are not gone in 2-3 months they will have to be bulldozed.

Florida Public Utilities has increased rates by 8% effective Sept 30th. A second rate increase of between 30 – 35% will take place on January 1st 2008.

Platinum Properties Update

Hours before the auction of Winslow Estates land (as part of Foreclosure proceedings following action by a group of creditors and buyers); Platinum Properties filed for Chapter 11 Bankruptcy protection. The land was subsequently removed from the auction on the courthouse steps on September 21st 2007.

Under the terms of Chapter 11, Platinum
Properties will be protected from creditors and
lawsuits whilst they seek to reorganise the
company. They must file a plan to the courts
within 30-45 days. This must be approved by
the courts. The protection will allow Platinum
Properties to seek new financing that can be
spent on infrastructure and building, rather than
paying down past debts. Platinum Properties has
three developments; Winslow Estates, Millbrook
Manor and Citrus Gardens.

Hopeful owners will be asked by the courts for a one time decision of whether they wish to walk away and lose their deposit, or if they wish to stick with the project.



Lake Conway

Our excerpts last month from a Florida history text book reminded Peter Stanhope, of the Florida Brits, of research he undertook in Florida looking at early English settlers. Peter contributed to an historical series run in the Orlando Sentinel, extracts of which are below together with some more history of the Lake Conway area.

Nowadays Lake Conway is located just north of where Sandlake/McCoy Road meets the Beachline Expressway. The lake itself is a chain of 3 main lakes surrounded by subdivisions.

In the spring of 1843 Benjamin F. Whitner Jr., Deputy Surveyor for the territory of Florida, came upon an unnamed lake. His field notes recorded the event as "28.43 chains (Surveyor talk) to clear open lake, (which being unnamed, I have called Lake Conway).

Settlers trickled in to settle around Fort Gatlin (built in November 1838) and there are shops, churches and parks etc still bearing the name Fort Gatlin. The first Church was founded in the 1880's and stood on the corner of Anderson and Conway roads. Around the same time English colonists started following adverts for orange groves in the British papers. Investors were buying large tracts of Florida for around a dollar an acre to sell on with claims of a "certain annual income of at least \$10,000 when the groves had reached maturity."

The British seemed to like the Lake Conway area. The whole episode "seems typically British to my mind, particularly for the period," said Peter. The speculators found a "lucrative source of investment from the landed gentry of Britain", who sent their younger sons out to seek their

fame and fortune.

As younger sons inherited nothing from the family estate it seemed a good idea to send them off to some imagined Utopia in Florida to make a name for themselves. They were fuelled by a monthly remittance to keep them going until they settled in. "They became known as remittance men because they were always waiting from the next check to come through the mail from daddy back home," said Peter.

William Blackman's 1927 History of Orange County recounts a lovely tale of new young English arrivals who returned to their Kissimmee hotel and "running true to English form, placed their shoes outside the door to be polished. Much to their disgust they found the shoes in the morning where they had left them, untouched, and were assured by the young English clerk that they were 'jolly lucky' to find them at all."

Captain Dudley G. Cary-Elwes (1873 - 1914) was a particular leader of the English group in the Conway area. Cary-Elwes served with Her Majesty's Third Infantry in Corfu in 1857, India in 1858 and China in 1859 -61 before heading to Florida with his family some 20 years later. Blackman reports that the family 'entertained liberally' at their large house on Lake Fredrika, north-east from Lake Conway. The house boasted stables and tennis courts and became host to regular tennis sessions on a Wednesday for other young English settlers. The English colonists were very sporty, enjoying shooting the local game of deer, quail and pigeon - there were no game laws at the time - and they cycled everywhere so much that a cycle path was created to Orlando. They also founded the Conway Yacht Club and the Conway Polo, rugby and cricket clubs.

As we have read, some of this group had independent finances (the remittance men), but many others had to take local work as labourers, waggoners, carpenters and the like to keep the money flowing as they waited for their groves to mature.

The 'first' English colony came to an abrupt end when back-to-back freezes in 1894-1895 devastated crops. Many English just fled back to England, according to Blackman "precipitately, some 200 together, abandoning groves, homes, furniture, with tables set and dishes unwashed."

Of course the second colony is ongoing now, as Brits continue to try and live the dream. But quite literally replacing the orange groves, vacation homes seem to be the crop either to own or manage!

The Legend of Spook Hill

We couldn't have an October issue without a little "spookiness"!

After the Seminoles left the Cherokee nation, they settled in Central Florida away from the white man's lodges to the North. One legendary chief settled on the lake which is now known as Lake Wales. Here he had all the advantages of a high campsite on a lake which offered fresh water and good fishing. It was also close to Iron Mountain which, as the highest point in Florida, was sacred to the Indians' Sun God.

The chief, Cufcowellax, and his people were happy for several years, but then one day a huge bull alligator moved into the lake and began to harass the tribe. Soon it began nightly raids on the village, and the tribe lived in terror of this evil spirit that inhabited their lake.

The legend says that Cufcowellax was a chief of great physical prowess and courage. He had great stature among his people both as a warrior and as a ruler. When he saw his people in constant fear, the chief, fearing for their safety, set out to conquer the evil spirit. His tribal shaman and elders placed him under the protection of the Great Spirit and he began his search.

Though many suns came and went, he could not catch the 'gator. Finally one morning he came upon the 'gator on the northwest shore as it dragged another night's victim into the lake.

The legend says the chief battled the 'gator on land and water for a moon, and then suddenly the great thrashing stopped, and the water of the lake turned red.

The tribe watched the surface of the lake in fearful anticipation. With great joy they saw their chief rise from the water. In the midst of their celebration they saw something else. The great battle had made a smaller lake near the big one. When the chief died, he was buried on the shore of the little lake, Ticowa, and the place became sacred to the Indians.

Discovery of Spook Hill

The Indians lost their camping grounds to the encroaching white settlers. Circuit riders carrying mail between the coasts used the old trail around Lake Ticowa until they discovered that their horses were laboring downhill. It was they who first called the place Spook Hill.

Spook Hill is on North Wales Drive, Lake Wales, which is about an hour south of Orlando just off

US 27. On the rural stretch of road, the town has helpfully erected a sign stating the legend and painted a white line on the road. If you pull up to the white line, leave the car in neutral and get out, you will be able to witness your car rolling up hill!



The town has wholly embraced the legend, the local school is called Spook Hill Elementary, which has given it a totally maintenance free tourist attraction! The legend sign below stands by the spot:

Theme Park News

Cypress Gardens has been sold again for the third time in just 12 years. Previous owner Ken Buescher will remain as CEO of the park following its sale at a bankruptcy auction to Mulberry-based Land South Holdings for \$16.8 million. Buescher was in \$135 million debt, and was forced to sell Cypress Gardens Adventure Park, and his other park, Wild Adventures Theme Park in Valdosta, Ga, as part of parent company Adventure Parks Group LLC's Chapter 11 bankruptcy. Buescher said no employees would lose their jobs, and all annual passes would be honoured.

The Popeye ride at Universal Studios Islands of Adventure was superficially damaged by flames following a fire in a diesel truck in the early hours of the 11th September. There were no suspicious circumstances and no one was injured.

Following the high profile recall of various toys manufactured in China, Walt Disney Corp have announced that they will begin random testing of the toys manufactured on their behalf to ensure their safety.

Disney theme parks have increased parking charges by \$1 to \$11 per day.

Disney Cruise Line is to double in size from two to four ships by 2012. The new vessels will be significantly larger at 124,000-tons and 1,250 cabins compared with the existing 83,000-ton ships – Disney Magic and Disney Wonder – which each have 875 cabins.
